- Park in spots 61-67 or 35-43. If all spots are full, ask a staff member where to park. Enter door 2 (under IFP Logo sign) & go up one flight of stairs.
- Be prepared to be at our office between 3 to 6 hours. You may take a short break for lunch if necessary.
- Unless accompanied for official reasons, do not bring anyone with you who is not being tested.
- NO CELL PHONES / ELECTRONIC DEVICES ARE ALLOWED. Please store them in your vehicle or with staff.
- NO WEAPONS ARE ALLOWED. PLEASE SECURE ANY WEAPONS BEFORE ENTERING IFP.
- SNOW POLICY: In the event of a snowstorm, IFP will be closed if the Oakland, NJ High School (Indian Hills) is closed. High school closing information can be obtained at (201) 848-SNOW or on our website www.ifp-testing.com.

FROM N.J. TURNPIKE. Exit 16W. Go West on Rt. 3 (which becomes 46W) for a total of 9 miles to Rt. 23N. Follow Rt. 23N for 7 miles to Rt. 287N. Take 287N for 5 miles. Take Exit 58 (Oakland). At end of the exit ramp, there is a light. Make a left. Stay in the right lane, proceed about 200 yards and turn right onto Ramapo Valley Road / 202S. Go 1 mile to Spruce Street and turn right (law office on corner).

Go down Spruce Street. Turn Right onto Fir Court. This is an office building area. Continue end (which is \boldsymbol{a} cul-de-sac). Turn left into Fir Court. Park only as instructed above.

FROM RT. 287 (GOING NORTH). Take Exit 58 (Oakland). This is about 16 miles north of Rt. 80. At the end of the exit ramp, there is a light. Make a left. Stay in the right lane and turn right after about 200 yards. Go over R/R tracks. Go 1 mile to Spruce St. and turn right (law office on corner). Proceed as in bold italics above.

FROM GARDEN STATE PARKWAY (GOING NORTH). Take Exit 160. At light at end of exit, turn left. Follow through 2 lights, past Wendy's, over the overpass and immediately turn right onto the highway below (Rt 4W). Proceed 200 yards and follow to 208N (towards Oakland). Follow 208N for about 9 miles. Merge onto 287S. Take first exit, Exit 58 (Oakland). At light, turn left. Go 1 mile to Spruce St. (law office on corner), turn right. Proceed as in bold italics above.

FROM GARDEN STATE PARKWAY (GOING SOUTH). Exit 162. Take Rt. 17S to Rt. 4W. Follow to Rt. 208 (Oakland). Take Rt. 208N about 9 miles. Merge onto Rt. 287S. Take first exit, exit 58 (Oakland). At exit's light, turn left. Go 1 mile to Spruce St. (law office on corner). Turn right. Proceed as in bold italics above.

FROM NY STATE THRUWAY / 287 (GOING SOUTH) (FROM NY & CT). Follow NY Thruway South to Exit 15 (NJ). Take Rt. 287S towards Morristown to Exit 58 (Oakland) (8 miles). At light at end of exit turn left. Go 1 mile to Spruce St, turn right. Proceed as in bold italics above.

FROM 17 (GOING NORTH). Proceed to Rt. 287S. Take Rt. 287S to Exit 58 (Oakland) (8 miles). At end of Exit 58 turn left. Go 1 mile to Spruce St., turn right. Proceed as in bold italics above.

FROM 17 (GOING SOUTH). Exit at Rt.4W. Proceed about 1 mile to Rt. 208N toward Oakland. Follow Rt. 208N for about 9 miles. Merge onto Rt. 287S. Take first exit, Exit 58 (Oakland). At light, turn left. Go 1 mile to Spruce St. (law office on the corner). Turn right. Proceed as in bold italics above.

FROM RT. 80 (GOING WEST). Follow Rt. 80W to Rt. 287N. Proceed for 16.6 miles to Exit 58 (Oakland). Turn left at light at exit, go about 200 yards and turn RIGHT over R/R tracks onto Ramapo Valley Rd. (Rt. 202S). Go one mile. Turn right at Spruce St. (law office on corner). Proceed as in bold italics above.

FROM RT. 80 (GOING EAST). Follow Rt. 80E to Rt. 287N. Proceed for 16.6 miles to Exit 58 (Oakland). Turn left at light at exit, go about 200 yards and turn RIGHT over R/R tracks onto Ramapo Valley Rd. (Rt. 202S). Go one mile. Turn right at Spruce St. (law office on corner). Proceed as in bold italics above.

FROM RT. 280 (GOING WEST). (FROM NEWARK). Go West on Rt. 280 for 13 miles and merge onto Rt. 80W. Follow Rt. 80W for 2.5 miles and merge onto Rt. 287N (Towards Mahwah). Proceed for 16.6 miles to Exit 58 (Oakland). Turn left at light at exit, go about 200 yards and turn RIGHT over R/R tracks onto Ramapo Valley Rd. (Rt. 202S). Go 1 mile. Turn right at Spruce St. (law office on corner). Proceed as in bold italics above.
